TERMS AND CONDITIONS - PLEASE INITIAL

- ___ 1. I agree to provide my cat with adequate food and water, proper veterinary care whenever necessary, including annual exams and vaccinations as the veterinarian recommends, and appropriate exercise and socialization.
- ___ 2. I agree to give my cat appropriate time to adjust to his/her new home using the **3-3-3 Procedure: 3 days to decompress. 3 weeks to feel comfortable, learn routines. 3 months to feel at home, settled in, trust.**
- ___ 3. I agree that my cat will be a family companion and live in a private residence.
- ___ 4. I agree never to declaw my cat **under any circumstances** and will contact Tiplings if scratching becomes an issue.
- ___ 5. I agree to supervise all interactions between my cat and young children.
- ___ 6. I agree that this cat will not be given as a surprise gift, given away, or sold. I agree not to transfer this cat to another person without written permission from Tiplings.
- ___ 8. If I move, I agree to make every effort to find a place where my cat will be allowed.
- ___ 9. Should I no longer be willing or able to keep this cat, I agree to return the animal to Tiplings.
- ___ 10. Should I have a question or concern regarding this cat, I agree to contact Tiplings.
- ___ 11. I agree that any and all expenses incurred after adoption are entirely my responsibility.
- ___ 12. I agree that Tiplings will not be responsible for any accidents, injuries, or illness arising from the adoption of my cat. Tiplings does not guarantee the health or temperament of this animal.
- ___ 13. I understand that Tiplings does not refund the adoption fee for a returned animal.
- ___ 14. I agree to surrender the animal to Tiplings, if there is any violation or breach of this contract.
